**NEW BUSINESS**

**A. *CONSIDERATION OF APPOINTMENTS AND RE-APPOINTMENTS OF MEMBERS OF THE MEDICAL-DENTAL STAFF – JIM ROGERS, M.D.***

CONCLUSION: The bylaws of the Medical/Dental Staff (Article 6.4) authorize the President/Chief Executive Officer to extend expiring privileges of practitioners until the next meeting if the December meeting of the Board of Managers is cancelled. Although this authority has been exercised in previous years, the JCAHO surveyors have determined that this authorization violates JCAHO standards if the extension will permit a practitioner's privileges to exceed two years.

Since privileges expire on December 31 (approximately one-half expire in the odd numbered years and the other half in the even numbered years), extension of privileges until the January Board meeting will violate the JCAHO standard for approximately one-half of the credentialed staff.

Drs. Rogers and Strodel presented the names of the individuals under consideration for appointments, change of status, one year provisional status, continuing provisional status, ending appointment, reappointment for 2001, provisional reappointment, and dual re-appointments to the Medical-Dental Staff of the University Health System (listing attached).

RECOMMENDATION: .On behalf of the Executive Committee of the Medical-Dental Staff, Dr. Strodel recommended approval by the Board of Managers.

ACTION: A **MOTION** for approval of the recommendation was made by Mrs. Williamson and **SECONDED** by Mr. Edmonson, and **PASSED UNANIMOUSLY**.

EVALUATION: None.

FOLLOW-UP: Mr. Turner will recommend bylaws changes in the near future to conform to JCAHO standards regarding the credentialing of staff.

**COMMUNICATIONS**

Mr. Hernandez participated in a legislative briefing by Bexar County Commissioners Court at which he introduced the University Health System's legislative agenda. The agenda was favorably received by those present.

Mr. Turner reported that because the federal budget was recently signed, health care organizations will see a fair amount of relief for the Medicare cuts that occurred in 1997, as well as, improvement in payments and restoration. In addition, in response to the Health Insurance Portability and Accountability Act of 1996 (HIPPA), he has appointed a task force to evaluate legal, regulatory, process, security, and technology aspects to each rule because there are significant criminal and civil penalties for non-compliance, as well as serious liability risks for unauthorized disclosure of health information that identifies individual patients.
